On 12/09/2023 at approximately 2355 hours I was on routine patrol in the 2600 block of 8th Avenue when I observed a vehicle traveling southbound on 8th Avenue at a visually estimated speed of 36 miles per hour (MPH). With a strong, steady, tone my vehicle radar locked the vehicle traveling 39 MPH in a posted 25 MPH zone. That day my radar was self-tested at the start of my shift at 1700 hours. I got behind the vehicle and identified it as a gray Subaru Crosstrek bearing a black Colorado license plate. I turned on my overhead red and blue lights initiated a traffic stop in the 2700 block of 8th Avenue and the vehicle proceeded to turn right onto 27th Street. The vehicle proceeded west on 27th Street approaching 9th Avenue when I pressed my air horn in an attempt to get the vehicle to stop but it continued to drive away. At the intersection of 27th Street and 9th Avenue, the vehicle had slowed down enough that I had enough time to get a Colorado license plate DYJZ40. The vehicle proceeded to travel northbound on 9th Avenue but then began to drive in the dirt median in between 9th Avenue and the back parking lot of King Soopers to avoid the speed bumps on 9th Avenue. The vehicle turned left to travel west on 26th Street at a fast speed. I was at 9th Avenue and 26th Street when I lost a visual of the vehicle when it turned right onto northbound 11th Avenue from 26th Street. I took a photo of my radar and uploaded it into evidence. I sent out a bolo to surrounding agencies and included the description of the vehicle that I saw; 2013-2017 Subaru Crosstrek with a sticker on the back windshield. It had a black roof rack and a black license plate with a green 2024 registration tab.

Dispatch later informed me that the plate came back to a white Jeep out of Broomfield. I had dispatch contact the Adams County Sheriff's Office (ACSO) to contact the owner of the Jeep. ACSO informed me that the vehicle had both plates on it and passed on the owner's information to me. At this time no new leads have been found. More follow-up to come.

On 12/11/2023 at approximately 19:20 hours I spoke with ownership at 2750 8th Avenue (White Horse Tavern) to obtain permission to view their security video system reference this case. Ownership provided me access to view video footage from 12/09/2023, primarily the camera that faces 8th Ave. to the west.

I viewed video from about 23:30 to 00:00 and was not able to see any other footage of the vehicle in the area prior to Officer Hewell attempting to conduct a traffic stop. I identified the vehicle. I was able to reach this conclusion due to the distinctive taillights on the Crosstrek.

On 12/13/2023 I conducted a search of license plate reader photographs. Utilizing a partial search of the license plate prefix DYJ I was able to find a photograph of license plate DYJZ48. The plate in the photograph was affixed to the rear of a 2016 Silver Subaru Crosstrek, registered to Salas, Sofia at 1321 2nd Street, Greeley. I printed the photograph and had Officer Hewell review it to see if it was the vehicle that eluded her. Officer Hewell confirmed that it was the same vehicle, and told me that the distinctive sticker on the rear window made her absolutely certain.

I accompanied Officer Hewell to 1321 2nd Street to locate the vehicle. On the north side of the residence, we both observed the same Subaru Crosstrek from the photo with the DYJZ48 plate affixed to the rear.

While doing a follow-up on this case for me, Officer Billings reviewed camera footage at White Horse Bar which showed me attempting to pull over the vehicle.

On 12/13/23 Officer Billings informed me that he was able to find the plate correct plate of the vehicle. He informed me that I got the last number wrong and that the plate was actually DYJZ48 . The plate was registered to Sofia Salas in Greeley. Officer Billings was able to use a police database and show me a picture of a Silver Subaru Crosstrek with a black Colorado license plate DYJZ48 and a decal in the middle of the back windshield of an outline of an unknown vehicle.

Officer Billings and I drove past the address listed on the DMV return and observed the vehicle parked in the back of the house bearing the black Colorado license plate DYJZ48 with 2024 green tabs. The vehicle had the same black roof rack and in the middle of the back windshield was a white decal of an outline of an unknown vehicle. I was able to visually identify the vehicle as the one from the traffic stop. Due to reported previous experiences at the residence and not having the resources, I will be attempting to make contact with the registered owner tomorrow at the house.

On 12/14/2023 Sergeant Amick, Officer Billings, and I all responded to the address of 1321 2nd Street Greeley, CO 80631 where the car was last seen. I drove into the alley behind the house and saw the same silver Subaru bearing the black Colorado license plate DYJZ48 with green 2024 registration tabs sitting in the back. I observed that the vehicle had been altered and the sticker on the back windshield had been removed. As I got closer to the vehicle, I observed that there was scratch damage on the windshield where the decal of the unknown vehicle once was.

Sergeant Amick and I contacted a female who was later verbally identified as the registered owner of the Subaru. The female, Sofia Salas, told me that the vehicle was hers and that she was the only one who had possession of it. I asked her if she was out driving the night of 12/9/2023 when the incident happened and she told me no that she would've been sleeping during those hours. I asked Sofia who would be driving the vehicle and she continued to say no one. I informed Sofia that I would be towing the vehicle due to it being used in the commission of a crime unless I could get a lead on who the driver was that night. Sofia told Sergeant Amick and I that we should know that she couldn't give us the information on who was driving and went inside.

The vehicle was towed by Superior Towing to their tow lot with a police hold on it. Sofia was given a copy of the towing sheet and both Sergeant Amick and I's business cards before we left. I have removed the local want on both the vehicle and Sofia. I will be changing this case status to "open." All evidence and documents have been uploaded into this case. No further police action taken.
